#### SUBDIVISION CARE AND FRIENDLY REMINDERS

- Homeowners with yards that back on Duncan Road, it is time to trim your trees up again so that there is at least 8' of clearance on the sidewalks (per the covenants) This is helpful for the safety of pedestrians. Those in non-compliance with the covenants will receive notices.
- All garbage cans/toters must be out of sight when it is not collection day. Cans may not be left near the front of the house (where they can be easily seen from the road) to improve the aesthetics of our neighborhood. Placing them in a non-visible place is appreciated! Those in non-compliance with the covenants will receive notices.

#### **Commons and General Subdivision Updates**

This fall, the board approved the purchase of three new fountain pumps to replace those that had worn out after 11+ years of service. All the fountains have now been removed for storage for the winter by our contractor, Solitude, Inc. Additional wiring replacement will be needed on the small pond, as a muskrat chewed through the power cord on the fountain so it would no longer work. Estimates are being requested for the repair with animal sheathing added to the cable to protect it from further damage.

The silt bag located near the large lake is still draining from the small pond silt removal project this past summer. It takes approximately 8 to 10 months depending upon the weather for the bag to drain fully. Once the silt has dried out appropriately, the commons area will be renovated in late spring or early summer 2024. Watch for more updates on this project!

Board member, Heather Miller, worked with the City of Champaign arborist this summer and fall to identify trees needing trimmed and those needing removed in the subdivision boulevards. Several dead trees have already been removed and the arborist continues to work on trimming as crews are available. # **Park Project**

The mini-park project planned for the empty commons lot (along Alpine Drive) reported on at the HOA annual meeting is continuing along it's planning and approval processes with the Champaign Park District and City of Champaign. The lot was surveyed over the summer and the Park District worked on the many internal approval processes along with the Park District's and HOA lawyers and the city engineer's office. The final project approval rests with the Champaign Park Board. The project must be voted on for inclusion into the Park District fiscal budget before the project can be implemented. The Park District anticipates the mini-park approval in the next couple months and some work to begin late spring/early summer. Watch for updates as they become available!
