Vandalism at the Small Lake

On Saturday, January 11th between 3:15 and approximately 3:45pm, three males in their late teens or early 20's were seen by multiple homeowners with shovels down by the small pond. They were digging out the rip-rap rocks around the small lake and tossing them out onto the frozen pond trying to break the ice. This causes loss of the important erosion control provided by the rip rap once spring thaw occurs.



The vehicle was caught on multiple home cameras and is seen above. It traveled west on Timberline, north on Meghan Drive. COMMONS AND LAKES UPDATES

- The City of Champaign Engineering group has been working with Farnsworth Group for the
 past 6 months to address concerns expressed by the HOA Board about the water and
 sediment flow into our detention ponds. No update has been provided to the HOA as of the
 date of this newsletter, but we hope to have more information by the spring, as this will be key
 to making some needed improvements to our detention ponds/lakes.

ARCHITECTURAL APPROVAL REQUESTS

TVN residents who wish to make improvements to their properties/home need to remember to submit a request to the HOA to approve your project. This is not intended to hinder anyone, rather to ensure that everyone stays within compliance of the covenants and follows the same polices. This includes SOLAR PANEL installations. The city engineers worked on projects in our subdivision including on Alpine Drive this fall More improvements are under consideration as budget allows for the panel repairs on the areas of most concern. Any service request submitted will automatically be forwarded and entered into the Public Works Department's work order system. Staff will monitor SeeClickFix service requests during normal business hours, which are 7:30 a.m. to 4:30 p.m. Monday through Friday.

FINAL NOTES....

- New policies regarding rentals and Air B&B's in the subdivision are now available online on the TVN HOA website. The board worked with the subdivision's legal counsel to create language that is enforceable. The board will be reviewing the number of rentals in the subdivision that are currently in place, and will be enforcing the new polices. No new rentals can be established until the number of rentals drops below 15 again. Additionally Air B&B's are no longer allowed to be in operation in TVN. - All garbage cans/toters must be out of sight when it is not collection day. Cans may
 not be left near the front of the house (where they can be easily seen from the road)
 to improve the aesthetics of our neighborhood. There are still many homeowners who
 have not corrected this on their property, so please complete this soon. Those in
 non-compliance may receive notices and/or potential fines.
- Assessment letters will be sent out again regarding those who have outstanding
 payments for dues and other fines. Be sure if you have not paid your HOA dues, special
 assessment dues from last summer or you owe for other fines, please settle those up
 as soon as possible so they do not become a lien on your home.
- Insurance The HOA Board is investigating new options for insurance that the HOA is
 required to carry for the commons and directors/officers. Bids have being requested
 for consideration; it is anticipated that the HOA will be able to save money in the
 budget based upon the bids already received.
- Remember to lock your vehicles at all times (even in your driveway) to protect your valuables. It is recommended you take high value items inside with you in the evenings. TVN and other area subdivisions had some minor break-ins in the fall. Leaving your outside lights on and adding cameras to your home also helps safeguard our subdivision! We have extremely low crime in our area and if we help each other and speak up if we see something, that will continue.
